

HİTİT BİLGİSAYAR HİZMETLERİ A.Ş**PRIVACY NOTICE FOR HİTİT PARTNER'S EVENT 2026 PARTICIPANT****a) Data Controller**

Your personal data may be processed by Hitit Bilgisayar Hizmetleri A. Ş. ("**Hitit or Company**") as the data controller in accordance with the Personal Data Protection Law No. 6698 ("**Law**") within the scope specified below.

b) Purposes and Legal Grounds for Processing Personal Data

The collected personal data may be processed for the following purposes ("**Purposes**") and legal grounds and within the scope of the personal data processing conditions and purposes specified in Article 5 of the Law.

Based on the legal ground that processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject;

- Your identity, contact and audio/visual recording data for the purpose of carrying out operational processes by our relevant business units for the design and execution of the Hitit Partner's Event 2026 ("**Event**") organized by the Company,
- Your identity and contact data for the purpose of ensuring your participation in the Event,
- Your audio/visual recording data for the purpose of taking photos and videos within the scope of the Event,
- Your identity, contact and audio/visual recording data for the purpose of creating the Event material.

Based on the legal ground that it is expressly provided by the laws and is necessary for fulfilment of the legal obligation to which the data controller is subject;

- Your identity, contact and audio/visual recording data for the purpose of fulfilling the requests of official authorities,
- Your identity, contact and audio/visual recording data for the purpose of providing information to the competent official authorities pursuant to the legislation,
- Your identity, contact and audio/visual recording data for the purpose of ensuring compliance with the retention obligations stipulated in the legislation,
- Your identity, contact and audio/visual recording data for the purpose of responding to data subject requests in accordance with the legislation and taking necessary actions,

Based on the legal ground that data processing is necessary for the establishment, exercise or protection of any right;

- Your identity, contact and audio/visual recording data for the purpose of constituting evidence in possible future disputes,
- Your identity, contact and audio/visual recording data for the purpose of receiving, evaluating and finalizing your requests and complaints.

Based on your explicit consent;

- Processing your identity, contact and audio/visual recording data for the purpose of carrying out the events, organizations and projects organized by the Company and introducing them to the public by visualization, providing information, raising awareness by conducting publishing activities on visual platforms within and outside the Company.

c) Recipient Parties and Purposes for Transferring Personal Data

Your collected personal data may be transferred **for the above-mentioned Purposes**; to our business partners, the organizations to which we provide services, and suppliers from whom we receive services within the scope of our legitimate interests, to legally authorized public institutions and private individuals within the scope of expressly provided by the laws and is necessary for fulfilment of the legal obligation, to our foreign business partners, the organizations to which we provide services, and suppliers from whom we receive services within the scope of standard contractual clauses published by the Personal Data Protection Board pursuant to the data processing conditions specified in Article 5 of the Law and in accordance with the rules regarding the transfer of personal data specified in Articles 8 and 9 of the Law.

d) Method for the Collection of Personal Data

Your personal data may be collected in the electronic environment via photo and video shooting within the scope of fulfilling the above-mentioned Purposes.

e) Rights of the Personal Data Subjecty Listed in Article 11 of Law No. 6698

According to adjustment in Article 11 of Law No. 6698; you have the right of

- Being aware of whether their personal data are processed,
- Requesting information regarding the personal data if they are processed,
- Finding out whether your personal data are used in accordance with the purpose of processing and their purpose,
- Being aware of the third parties to whom personal data are transferred at home or abroad,
- Requesting the correction of personal data in case of incomplete or incorrect processing and requesting the notification of the transaction made within this scope to the third parties to whom the personal data are transferred,
- Requesting the erasure or destruction of personal data in the event that the reasons requiring processing are eliminated despite being processed in accordance with the provisions of the Law No. 6698 and other relevant laws, and request the notification of the transaction made within this scope to the third parties to whom the personal data are transferred,
- Objecting to this if you think that a result to your detriment has arisen by analyzing your processed data exclusively through automated systems,
- Requesting compensation if you suffer damage due to unlawful processing of your personal data.

If you submit your requests regarding your rights to our company by the methods set out below, our company will finalize the request free of charge as soon as possible and within thirty days at the latest,

depending on its nature. However, if the transaction also requires a cost, the fee in the tariff determined by the Personal Data Protection Board will be charged by our Company. In this context, in accordance with paragraph 1 of Article 13 of Law No. 6698, you may submit your request to exercise your rights mentioned above to our company in writing or by other methods to be determined by the Personal Data Protection Board in the future. In this context, the channels and procedures you will submit your written application to our company within the scope of Article 11 of Law No. 6698 are explained below.

In order to exercise your rights mentioned above, you may submit a wet signed copy of the Data Subject Application Form, a sample of which is available at <https://hitit.com/themes/hitit/documents/2026-02/data-subject-application-form.pdf>, to "Hitit Bilgisayar Hizmetleri A.Ş.
